- 2. We did not review the interim financial information of one subsidiary include in the consolidated financial results, whose financial information reflect total assets of Nil as at June 30, 2019, total revenues of Nil lakhs for the quarter respectively, and total loss of 0.30 lakhs for the quarter ended June 30, 2019, as considered in the consolidated financial results. These interim financial information have been furnished to us by the Management and our report on the Statement, in so far as it relates to the amounts and disclosures included in respect of these subsidiaries, is based solely on such interim financial information.
