REFERENCE: INTIMATION OF REDUCTION OF ISSUE SIZE OF PROPOSED PREFERENTIAL ALLOTMENT OF EQUITY SHARE WITH DEFERENTIAL VOTING RIGHTS (“DVR SHARES”).

Dear Sir / Madam,

This is further to our intimation letter dated September 18, 2021, and October 08, 2021, and with reference to the captioned subject and mentioned reference, the Company had received an e-mail from the National Stock Exchange (“NSE”) dated September 01, 2022, requesting the Company to provide an undertaking/confirmation from all the proposed allottees that they are aware of Securities Appellate Tribunal (“SAT”) order dated August 11, 2022 expelling the Stampede Capital Limited (“the company”) from the membership of the exchange with a direction that the company shall close out any open position in the exchange traded derivative contracts within a period of three months and settle the pay-in and pay-out obligations in respect of transactions which have taken place before the date of the impugned order and the proposed allottees are still willing to subscribe to the DVR shares in proposed Preferential Issue.

Pursuant to the above, the Company has received the said consent from 17 allottees out of the total 25 allottees confirming to the requirements of NSE who will only be allotted DVR shares pursuant to the aforesaid issue. The offer letter in PAS - 4 shall be circulated to only those 17 allottees who have given their consent and are willing to subscribe to the DVR shares in the proposed Preferential Issue.
