# SUBJECT: REPORTING OF VIOLATION OF COMPANY'S CODE OF CONDUCT UNDER THE SECURITIES AND EXCHANGE BOARD OF INDIA ("SEBI") (PROHIBITION OF INSIDER TRADING) REGULATIONS, 2015.

### REFERENCE: SEBI CIRCULAR NO. SEBI/HO/ISD/CIR/P /2020/135 DATED JULY 23, 2020

### Dear Sir / Madam,

In furtherance to the captioned subject and reference, and also with reference to the disclosure dated January 24, 2023 submitted to the BSE Limited ("BSE") and to the National Stock Exchange of India Limited ("NSE") whereby Stampede Capital Limited ("the Company") reported about the violation of Company's Code of Conduct by one of the designated person of the Company i.e. GAYI ADI Holdings Private Limited (Formerly known as GAYI ADI Management and Trends Private Limited), the promoter of the Company ("the promoter Company"). The promoter Company inadvertently violated the provisions of SEBI (Prohibition of Insider trading) Regulations 2015, by buying 20,00,000 DVR Shares of the Company on January 20, 2023 @ Rs. 13/- per share subsequent to the invocation of pledge by Guardian Finance Private Limited.

In regards to the same, the Audit Committee of the Company levied the monetary penalty of Rs. 20,000/- in its meeting held on January 23, 2023. The Company deposited the said penalty of Rs. 20,000/- on February 24, 2023 with Investor Protection and Education Fund (IPEF) administered by the Board under the Securities and Exchange Board of India Act, 1992.
